The BZA consists of five members, all of whom are on call and must be residents of the jurisdictional area. It is compiled of three citizen members appointed by the President of the Town Council. Of these three members, one must be and the other two may not be members of the Plan Commission. One additional member must be a citizen appointed by the Town Council and may not be a member of the Plan Commission. The final member must be appointed by the Plan Commission from the Plan Commission and must be either a county agricultural agent or a citizen member of the Plan Commission other than the one appointed by the President of the Town Council. No members of the BZA may hold other elective or appointed office in municipal, county, or state government.
